


1. In order to confirm that there are no grounds for excluding an Economic Operator from a contract award procedure ("procedure"), the Contracting Entity may require the submission of the following evidence concerning the Economic Operator [Polish: podmiotowe środki dowodowe]:

2) the Economic Operator's statement, in connection with s.108(1)(5) of the Act, to the effect that the Economic Operator is not a member of the same group of companies (within the meaning of the Polish Competition and Consumer Protection Act of 16 February 2007 (Dz. U. [Journal of Laws] of 2020, items 1076 and 1086)) with any other Economic Operator that has submitted its own tender, a partial tender or an application for permission to tender for the contract, OR the Economic Operator's statement to the effect that the Economic Operator is a member of such a group, together with documents or information confirming that it has submitted its own tender, a partial tender or an application for permission to tender for the contract independently of any other Economic Operator that is a member of the same group;
